**IMPORTANT NOTICE:** Applicants **MUST** present proper IDENTIFICATION and bring the official document issued – "Texas Sales and Use Tax Permit" (bringing only your Tax I.D. **Number** is NOT acceptable). If the TX Resale Tax Permit is issued in an individual's name (not a business name), then the person whose name appears on certificate is the **ONLY** one who may apply.

- **VENDORS! Bring your own trash bags & can. Public barrels are for CUSTOMERS ONLY.**
- **DO NOT leave your unsold merchandise or containers. TAKE IT WITH YOU!**
